Object, purpose and legal basis of the processing:

Fornella srl informs you that your personal data (specifically and limited to your personal and common identification data, contact details, data relating to family status, tax and postal data, data relating to educational qualifications and career), as well as, any personal data of third parties (specifically and limited to personal data and common identification data, and tax data of your dependent family members, or in any case of members of your family nucleus) communicated by you, will be processed for the sole purpose of evaluating and analysing this application of hiring.
